We apply expertise gained from serving our clients to training, education, and advocacy to ensure that systems, laws, and policies enable immigrant survivors to break free from violence and exploitation.

By amplifying the experiences of survivors, our mission is to create a world in which all people share equal rights and live in safety and with dignity.

DIRECT SERVICES

We support survivors of violence through free legal and social services, from direct representation to emergency shelter, food, and health care. Access to these basic needs allows Tahirih clients to build lives of safety and comfort in a new and unfamiliar place.

POLICY ADVOCACY

We engage in nonpartisan public policy advocacy—centering the needs of immigrant survivors in communities, courts, and Congress—to ensure that laws and policies protect survivors' right to be free from violence and exploitation.

COMMUNITY OUTREACH & TRAINING

We educate thousands of frontline professionals on the unique obstacles that immigrant survivors face, giving communities the essential tools they need to help survivors in crisis.

In 2024, Tahirih Atlanta:

- Co-sponsored Stand With Survivors Day, a one-day lobbying event at the Georgia state capitol to speak to elected officials about legislation that affects survivors of domestic violence, their families, and communities.
- Provided training to three school districts including Fulton County, Marietta City, and Cobb County centered around best practices in working with immigrant survivors of gender-based violence and utilizing Tahirih services as a resource.
- Organized our first legal clinic in partnership with pro bono attorneys from Visa who assisted four families with their applications for the U visa.
- Co-hosted a community conversation with Kennesaw State
 University in which our Executive Director served on a panel
 to discuss the impact of harmful policies on underrepresented
 groups including immigrant survivors.
- Presented a workshop led by our Managing Attorney on immigration literacy and trauma-informed care at the Georgia Commission on Family Violence Statewide Conference.
